Due to the delay in the Government announcement about new towns Milton Keynes City Council (MKCC) have delayed the New City Plan

A briefing for Ward Councillors took place last week on the Community Governance Review. Ward Councillors urged the parish council to send in a response to the review with reference to the governance of the MK East development.

 - **6.1.1** To update on recent communications with St. Joseph (Developers of MK East)

Parish Council have had several meetings with St. Joseph to discuss the traffic calming measures that are included in the S106 agreement of the MK East planning application. A draft scheme has been drawn up and will be put to MKCC, from there a Public Consultation will be needed.

Assistance with advice upgrades to the hall and church has also been offered by St. Joseph.

6.1.2 To note recent meetings with Kay Pettit and Paul Van Geete

Parish Council have met with Kay Pettit (MKCC Programme Manager for Parish and Town Councils) and Paul Van Geete (MKCC Tariff Programme Manager) to discuss the impact of MK East on the parish council.

- 6.1.3 To agree to create Welcome booklet for new residents Council agreed to the creation of a Welcome Booklet to be included in any packs handed to residents moving into the area. Assistance with printing will be provided by MKCC.
- 6.1.4 To agree logo for new booklet A logo is needed for the Parish Council that can be used on the new booklet and correspondence. Style of first drafts was agreed with some alterations to colour and depictions of some items.
- 6.2 Community Governance Review: To note the contents of the Draft review and to confirm the position of Moulsoe Parish Council in relation to the governance of MK East to Democratic Service office at Milton Keynes City Council.
 Council had noted the recommendations in the draft review. Although the parish had not been highlighted for any change the parish council considered a response to the Head of Democratic Services was necessary to confirm in writing the intention of the parish council to continue to act as the parish council for the emerging communities in MK East. Clerk will send the council's response to MKCC before the consultation ends on 11 September.

 Clerk will check if MKCC Highways have an updated scan report of the road condition. This was noted as outdated when the Clerk attended a recent MKCC Highways meeting.

The application comment deadline was 9 September, as discussed with council via email the Clerk had responded to the application.

<u>PLN/2025/1358</u> - Outline application (matters of access and scale to be considered, with matters of layout, appearance and landscaping reserved) for the erection of one 3-bedroom dwelling at Park View, Cranfield Road, Moulsoe, Newport Pagnell, MK16 0HL

Council had reviewed the documents and raised concerns regarding the size of the property in relation to the plot, and also the increase in vehicle movements in and

out of the new property with limited visibility and at one of the narrowest points of the road through the village. Clerk will respond to MKCC planning with the council's concerns.

6.5 MKCC Household Support Fund: To discuss and agree an application for funds allocated to Moulsoe to be put towards ongoing coffee mornings.
Milton Keynes City Council has allocated £75,000 from its Household Support Fund to parishes so that they can continue to provide initiatives such as community cafes, community hubs, social clubs and wellbeing support, including 'warm places' and pop-up cafes. Moulsoe has been allocated £500 from this fund. Council agreed to apply for Moulsoe's allocation to continue with the village coffee mornings. Clerk
